Activity Consultation and Collaboration

Consultation

Consultation occurred with Kalwun during the 2019/20 period to inform a new model of service. This was commissioned in October 2019 and builds on the established approach of an integrated mental health, AOD and suicide prevention service. Further consultation was undertaken with Institute of Urban Indigenous Health (IUIH) in 2024 to understand corporate supports that could be leveraged through IUIH to support evidence of improved service outcomes for indigenous consumers.

As part of the implementation of the JRP, the Gold Coast AOD Strategic Partnership Group was established. This group had an established workplan and prioritised key activities for delivery over the past 24 months; outcomes have been achieved in governance and leadership, transition of care, establishment of improved referral pathways, and improved understanding of health equity goals and needs for the region.
